2.3.10 SAY ON PAY

The Supervisory Board reviewed the recommendation in paragraph 24.3 of the AFEP-MEDEF Code of November 2015, as well as the AMF's recommendations in its Position-Recommendation 2014-14 concerning the preparation of the registration document.

The Board also reviewed the AFEP-MEDEF code application guide updated in December 2015, and in particular the comments related to the completeness of information related to remuneration.

Based on the AMF's recommendations about describing the remuneration of managers, the Supervisory Board considered it appropriate to outline to shareholders the remuneration of the Management Company's corporate officers.

It therefore decided to submit the remuneration payable or attributed to Maurice Tchenio, legal representative of Altamir Gérance, Manager, and Monique Cohen - Deputy Chief Executive Officer of Altamir Gérance until 4 May 2015, for the financial year ended 31 December 2015, to a non-binding vote of shareholders.
